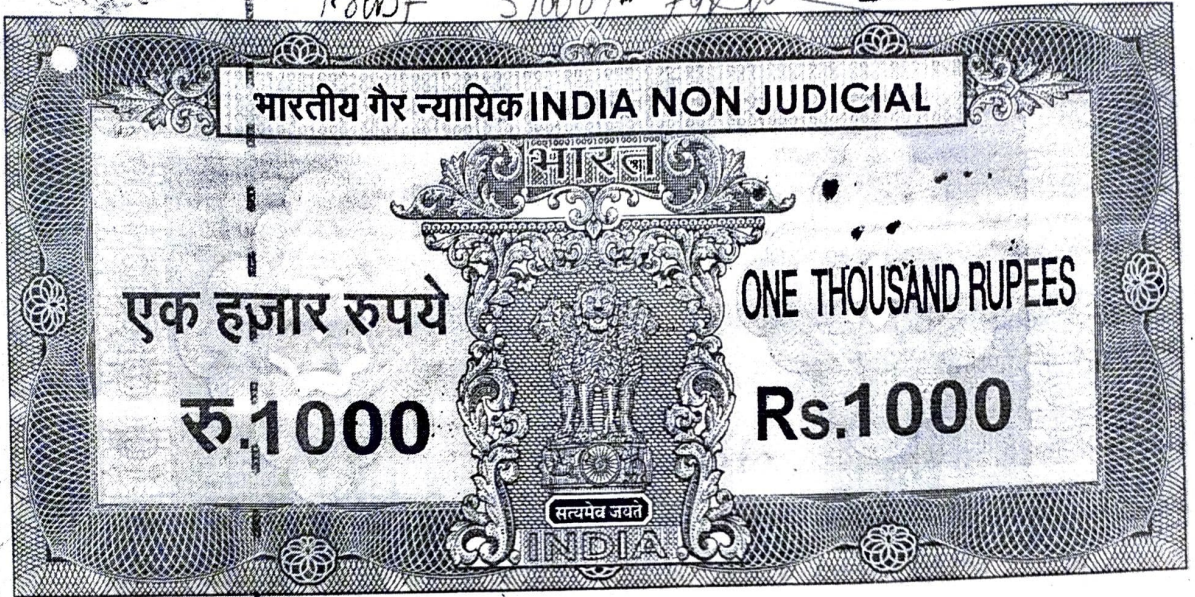

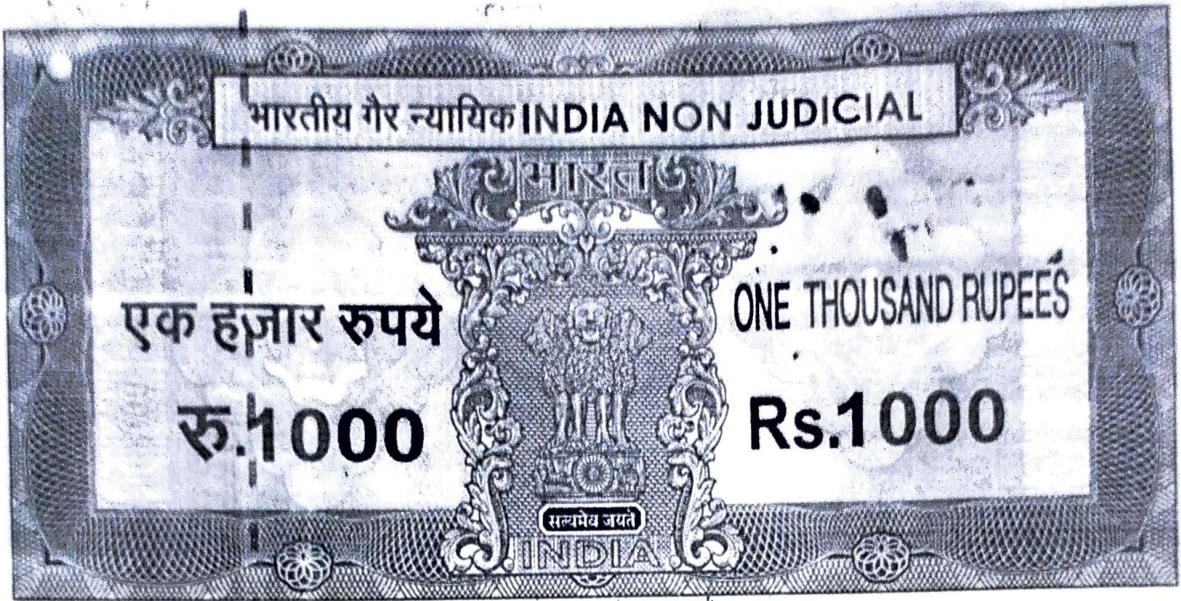

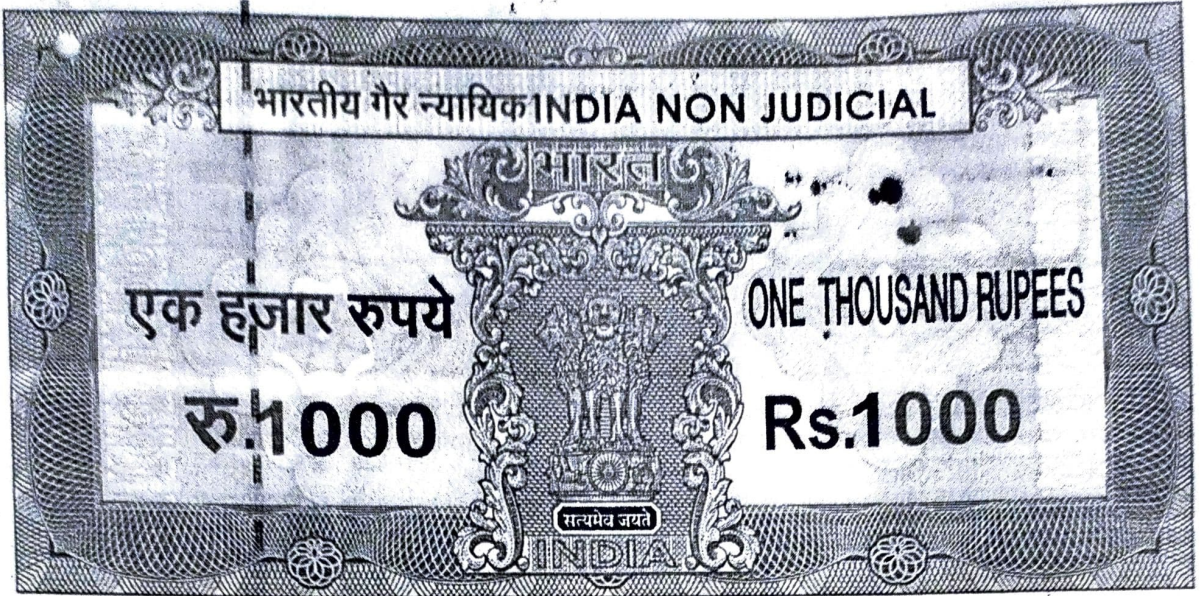

(xiv) To construct Low Cost Housing for the homeless and poor people in collaboration with Government authorities both Central and State, Trusts, national and international agencies and organizations, etc. ;

In the event of vacancy in the office of the Chairman, the Board shall elect a Chairman amongst themselves. If any of the trustees dies or desires to retire or refuse or become incapacitated to act as a trustee or take to the benefit of the Law of Insolvency, then and in every such case, there shall be a vacancy in the Board. If any member fails to attend three consecutive meetings, then his membership will cease after giving him notice with opportunity of being heard. Casual vacancies including vacancies created by removal, as stated earlier, may be filled up in the manner aforesaid upon passing of a resolution for appointment of a new trustee by majority of votes and in case of forming a new board of trustees all the properties of the trust will vest upon the newly formed trustees and no formal deed of appointment shall be required to be executed and registered. Vacancies in the Board shall not invalidate any of the proceedings of the board. The board may meet as often as necessary and in any event not less than twice in a calendar year. Declaration at the meeting of the board of trust shall be taken by a vote of the majority of the trustees present. In the case of equality of votes the chairman of the Board shall have a second or casting vote. The trustees may from time to time make regulations as to their meeting and the conduct of their business and otherwise as to the management of the affairs of the trust.

- (ix) To employ necessary staff for the management, control and administration of the Trust in general and for the institutions in particular ends for the purpose of carrying out the objectives of the Trust on such terms as may appear proper to the trustees and to delegate and to allot such staff from time to time such powers and duties as may be necessary in the useful course of business;
- (x) To takeover control and management of any unit or the whole of the Trust in case of an emergency or any untoward situation, for six months initially and for another six months or any longer period and to dissolve the executive council, committee, board or governing body, by a resolution of the Board and to appoint Administrator for the management of the Trust or any unit of the Trust.
- (xi) The Board shall have full power to amend, alter, delete, rescind, extend its rules, regulations and any clauses of this byelaw or any part thereof by passing appropriate resolution to be passed by majority of votes of the board of trustees.
- (xii) To do all acts and things which are connected with the administration of the trust in general and of the institutions in particular and which are deemed by the trustees to be the best in the interest of the trust and are desirable.

- (v) Sign on behalf of the Trust for all sums received as subscription, Donation, contributions, gifts, promissory notes, loans, grants, etc.;
- (vi) Sign and give pay orders on all bills or payments;
- (vii) Get the accounts of the Trust audited by a Chartered Accountant;
- (viii) Ensure compliance with statutory requirements; and
- (ix) Transact all other business subject to the direction of the Board of Trust.

Asst.- Secretary:

In the absence of the secretary, the Assistant Secretary shall perform all the duties of the secretary, and shall assist the secretary in all respect for smooth running of the Trust.

Treasurer:

- (i) Collect and receive all sorts of subscriptions, donations, gifts, loans, and deposit of money and grant receipts thereof;
- (ii) Maintain and keep cash book and such other accounts as are necessary;
- (iii) Prepare the budget in consultation with the Secretary for consideration of the Board of Trust.

(8) NOTICE AND QUORUM:

Seven days' notice of the meeting specifying the place, time and the general nature of work and business to be transacted shall be given to every trustee of the Board of Trust. Emergency meeting may be called on 24 hours' notice. Any one third trustees of the board of trust personally present shall constitute a quorum for the meeting and if a quorum is not present within 30 minutes of the time the trustees present may adjourn the meeting.

(9) MEETING:

A meeting of the Board of Trust shall be held as per requirement of the Trust at such place, date, time and agenda as the Chairman or the Secretary may determine. Any one third of the present Trustees of the Board of Trust may requisition the meeting and the Secretary shall summon the same within seven days.

(10) PROCEDURE OF THE MEETING:

The Chairman shall preside over all meetings of the Board of Trust and in his absence; present trustees shall elect a chairman of the meeting. All questions before the meeting will be decided by a majority of votes, each trustee having one vote. The Chairman shall have a 2nd or casting vote in the addition to his own vote in the case of equality of votes.

(11) EXPULSION & REMOVAL OF THE TRUSTEES:

A trustee / trustees may be removed from office for misconduct or for obstruction of the functioning of objectives of the trust or violation of Rules

and Regulations of the Trust by a resolution adopted by two third majorities of the trustees of the board of trust present and voting at a meeting specially called for the purpose. Frequent actions of any trustee, if found by the Board of Trust is detrimental to the interest and is in violation, he / she may be after the enquiry, censured, suspended or expelled from the trustee by the Board of Trust. In that case, the Board of Trust shall first serve notice upon the trustee with a show cause showing therein the charges framed and ask him to submit his statement of defence within twenty one days from the date of receipt of show cause notice. On receipt of the explanation, the Board of Trust shall have the power to take a suitable action against the delinquent trustee after allowing him to defend his case. If no reply to the show cause notice is received within the stipulated period or any extension of time allowed by the Board of Trust, the Board of Trust may take an ex-parte decision. For any act of expulsion or termination no such trustee shall be entitled to prefer any claim for compensation or damage even if proved on subsequent date that such act of expulsion or termination was wrongful and / or unlawful. If the aggrieved trustee does so it will not be enforceable before any court of law.

(12) RECEIPTS OF CONTRIBUTION ETC. & OPERATION OF BANK ACCOUNT OR ACCOUNTS:

All contribution to the trust shall be received by any of the trustees of this Board against a receipt duly signed by the Chairman /Secretary/Treasurer or any other authorized person competent to do so. The fund of the trust will be kept within the joint custody of the treasurer and one other person appointed by the Board of Trust. The trust shall maintain several savings bank accounts, deposit accounts, current accounts, loan accounts, special deposit accounts or any other special accounts either in the name of the Trust or in the name of any of the units or specific objectives of the Trust, such as Schools, Colleges, University, Training Centre, Institutions, and Health Care Centre, Hostel, Old Aged Home, Council, Committee, Project, Grants, Foreign Contribution Accounts, or any other description under the trust as may be resolved by the Board of Trust. All Accounts in the name of the Trust shall be operated by any two persons amongst the Chairman, Secretary and Treasurer as decided by the Board of Trust. Accounts maintained in the name of any unit / specific objectives of the Trust aforesaid mentioned shall be operated by 3 (three) persons out of the Board of Trust or persons outside the Board of Trust, as may be resolved by the Board of Trust. This is within the power of the Board of Trust to alter the above clauses of bank operation and may pass appropriate resolutions which they may think fit and proper in
